For the relationship between the opinion on the Quality Cycle and the Four Iddhipadas. By conclusion, the relationship between the opinions of the sample and the performance of Quality Cycle and Four Iddhipadas are positive correlation were correlatively high levels.

Which the properties, as the issue of graduate schools and universities must recognize and important, by must be controlled directing and monitoring the implementation of the criteria, because it is reflected in the quality and standard of graduate studies in the University itself. But the reality is there are many courses at the University, also not continue to meet the criteria at all in a short time, so effective to the quality and standard of education educate is not enough.

2.2.2 To promote and development teacher for the curriculum.

The graduate school or faculty, or the University should be plan and formulate development strategies for qualified teachers and the academic potential to increase (at least according to the criteria of OHEC in the year 2015), this is one of the main reasons that motivate people to come to and be accepted by society outside it. There is a famous university, require teachers with the knowledge and experience to do enough research or is recognized in academic circles. Which is an incentive for people to study and to do research on a thesis or dissertation very high quality, so that it's impossible to deny that the quality of education. 2.3 Quality Management of Graduate School and the University

1) The instructor of subject in the course or program, have documentation of teaching or textbooks at comprehensive material content as course description in the curriculum or program of study, by teaching cover material content in the curriculum set forth in TQF.3 Section 5 (15 weeks of 3 hour 45 hour).

2) The lecturers responsible of subject (determine in TQF.3) as the control, monitoring and evaluation of teaching instructor the subject (see the teaching, ask students and evaluating teachers responsible for teaching and or complaints from students).

3) The teacher responsible for the curriculum (as stated in TQF.2) to manage TQF.3 with a professor or instructor responsible for the course and that course, if found responsible for the course instructors and professors responsible for the course, there is not academic position (Asst., Assoc., Prof.) should invite teachers with such a position to prepare the TQF.3 Section 5 that “the lesson plan for 15 weeks,” which would make a lesson plan, content includes or content complete and more reliable.

4) The dean or vice dean who was assigned with the teacher responsible for the course of the control, monitoring and evaluation, instructional courses and a thesis or dissertation supervision standards and quality standards even further.

5) The rector or vice rector the delegates (out of order in relation to the preparation of simple thesis or dissertation and thesis or dissertation signed copies) to monitor and evaluate the quality and standard of the thesis or dissertation, clearly more.

Overall, the quality of the graduate educate, in addition to the criteria determine clearly, if lack of control supervision and monitoring of good quality, (it is powered systems and mechanisms) may be difficult to graduate students to gain knowledge and experience from the course and the preparation of a thesis or dissertation to quality, truly standards, its will affect the quality of the students and thesis or dissertation in the end.

2.4 Quality of thesis or dissertation and published

Thesis or dissertation of graduate students, who has done research for a thesis or dissertation, the knowledge this is part of the education program at Master or Doctorate level, if the thesis or dissertation quality and high standards. It is an indicator that the knowledge and experience of the students and refinement. The nature of the thesis or dissertation quality, which can be divided into two parts: as the quality of the content and quality of the presentation of a thesis or dissertation.

2.4.1 Quality of the thesis or dissertation

1) Consideration of system and device.

(1) Appointment of advisors **Independent Study** (IS) or **thesis** and a **dissertation** in a graduate educate as professional relationship consistent with the thesis or dissertation.

(2) Controlling section thesis or dissertation and dissertation graduate students in accordance with the study and advancement of the science itself.

(3) Assisting monitoring and conducting independent study or thesis and dissertation and published work in graduate students. Which allows the graduation criteria, (Mater's two-years and doctoral 3 years).

2) The thesis or dissertation content. Depend on the accuracy and value as important, in addition to the quality of the academic thesis or dissertation, also means compliance thesis 12 credits or compliance Dissertation 36-48 credits, which is require to guarantee the quality of graduate educate (Ministry of education, 2015), by requiring them, evaluate the quality and standards of the independent study (IS) or thesis and dissertation, which expert are specialized or highly qualified in science subjects for that always evaluate.

So that, the teacher standard of responsible for the curriculum. It is an important **References** mechanism in the drive to provide quality and standards (Master or Doctorate) in graduate educate. The benchmark academically then, executive and management courses or majors, there must be other roles, such as a network of specialists or experts, and academic cooperation. Which contributed heavily to help develop graduate students for teaching and research success. It will affect the quality and standards of quality and student thesis or dissertation in the end.

2.4.2 Quality publishing

Thesis or dissertation which have quality and standards, which is an indicator that the knowledge, capability and refinement of students. The feature of the thesis or dissertation which have quality and standards, can be divided two parts: the quality of the content, and presentational quality of the findings.

1) Content quality depend on the accuracy and value of academic science that is important, and the quality of the thesis or dissertation also refers to the quality of research, which means the requirement that the quality assurance (minimum) of a thesis or dissertation. By device academic standards and the standards of performance as follows.

(1) Academic standards is standard of knowledge, by the research result that must create, develop or discover new knowledge in science disciplines, which knowledge of the methodology is accurate, complete, perfect and there is a universal or global level, and accept, benefits for academic and or social.

(2) Performancal standards, are the standards related to the research process to strengthen and develop the capabilities of students, which is composition the structure of the curriculum with have credits numbers, thesis or dissertation, such as the prior time of a thesis (thesis not less than 4 months) and prior time to prepare a dissertation (dissertation not less 8 months), the qualification and the ability to research's students. The knowledge

ability and expertise of advisor for thesis or dissertation, including the support resource to research operation, and the process by the section: the research topic (consider the topic or problem and the appointment of a consultant's), to preparation of thesis or dissertation proposal, (committee to thesis or dissertation proposal examination), to perform for thesis or dissertation, and defended a thesis or dissertation or oral examination (appointment the committee for defense examination), which have the expert or Professional (Assoc.Prof., or Professor field that or relationship) and operational approval or certification of a thesis or dissertation. (By the Rector or the Vice Rector or Dean of the Graduate School to assigned).

2) Quality of the presentation to research result, in appearance a form, although each university, will determine the form to different (as determine in manual of thesis or dissertation) it is required to form a beautiful and meaningful understanding of this aspect of the thesis or dissertation quality and standard, must contain the following:

(1) Format, the format of a thesis or dissertation, must have the durability the materials used to make the outer cover and paper used in printing must have quality requirements. The binding must be completed and copies of the paper to the surrounding smooth.

(2) Length, the thesis or dissertation good, must have the length of content whit the appropriate (complete to methodology) is not much or too little, which show that the ability to use language of content have a concise and clear.

(3) Using of language to communicate, the thesis or dissertation doing both Thai and English languages, must use formal language (if the local language to explain the meaning intended) and because of the thesis or dissertation is a technical document, so that the use of words, phrases and sentences, so it requires the correct and appropriate to the material content of the research, based on the syntax of the language is, if in doubt or uncertainty for students to check out the latest edition of the dictionary and standardized consultants or experts.

(4) Accuracy of the information and publishing, thesis or dissertation are good and standard, trusted to be accurate in terms of content and proofreading (check by akarawisut), so that is the responsibility of the student and the advisor, must check the information content is accurate and true, and printing a thesis or dissertation, according to the form, or graduate school and each university set up.

(5) Publishing, because of research result in the graduate educate level, as a result of good quality and standard, also defined to be published for the benefit of the public by the (specified in the criteria. OHEC. The announcement go.th. 2013), particularly dissertation must be published in a journal or journals are data bases TCI), but observations from

past experience, (the author of this article as well as teaching graduate educate level, as a consultant and thesis or dissertation and five hundred stories, and a panel of experts (peer review) the reader research result to use the thesis or dissertation, before it was published in the journal of TCI Group 2 and Group 1, and conclude the thesis or dissertation that, quality and standards of the thesis or dissertation are different, so that, because the quality of the teacher responsible for the curriculum, thesis or dissertation advisor have the knowledge and an experience (flight hours), different and not equal.
